5 **TO CLAIM ACMPE CREDIT:**
Claim immediately by clicking **“Download Certificate.”**

TO CLAIM ACHE, CME, CNE and/or CPE CREDIT:

MGMA Staff will validate your attendance and license number within five business days, starting Oct. 26. If you are found ineligible to claim credit, you will be contacted by MGMA. Once approved, log back into the MGMA Continuing Education Submission portal as detailed above and click on **“Download Certificate.”**

TO CLAIM AAPC CREDIT:

Click on **“Download Certificate.”** The certificate will have the necessary codes for each session you attended to claim your credit with AAPC.

TO CLAIM GENERIC CEU CREDIT:

Claim immediately by clicking **“Download Certificate.”**
